Whilst some of our members were busy putting on a series of insightful events around youth participation and children deprived of liberty, the CFJ-EN hosted its first-ever **Child Justice Caravan** in Brussels in December with Young Justice Transformers from Greece and the Netherlands. We also hosted an **Academic Seminar** in Leiden in April, in partnership with Leiden University.

Meanwhile, the Operational Team is preparing to host its third **Annual Seminar on "Climate in-justice for children: How climate change affects Children's Access to Justice**". The Seminar - scheduled for 10 and 11 October in Brussels - will gather together climate experts and child justice professionals to promote the human rights of children affected by the consequences of climate change. - Impact litigation and children's access to justice
- Children's rights to free assembly
- Climate change and child justice systems
- Climate change and crimes committed by and affecting children

## **Policy Update**



UN Committee on the Rights of the Child: the upcoming General Comment No. 27 will centre around the topic of Children's Rights to Access to Justice and Effective Remedies: According to the <u>concept note</u>, this focus is crucial as access to justice serves as a vital tool in addressing inequalities, combating discrimination, and reinstating denied entitlements. Moreover, it enhances the accountability of both governmental and private entities in fulfilling their obligations.

Council of Europe: The Steering Committee for the Rights of the Child (CDENF) welcomed the adoption, on 6 September 2023, of Recommendation CM/Rec(2023)8 of the Committee of Ministers to member States on strengthening reporting systems on violence against children. The committee also welcomed the publication of a Mapping study on multidisciplinary and interagency child-friendly justice models responding to violence against children, called "Barnahus: a European journey". The study was produced with the support of the Icelandic Presidency of the Committee of Ministers. <u>Click here for the minutes of the last CDENF Steering Committee</u>.

European Commission: on 23 April, the European Commission adopted the Recommendation on developing and strengthening integrated child protection systems in the best interests of the child. This initiative addresses the urgent need for better protection amidst reports of widespread violence and bullying affecting millions of children across the European Union. Key focus areas for improvement include enhancing literacy, promoting safe technology use, protecting mental health, and combating bullying, including cyberbullying, with an emphasis on training professionals and improving intersectoral cooperation.

## Case Law

**ECtHR case of H.T. and M.T. v. Greece (2024) - Degrading Conditions in Samos.** The ECtHR has granted Interim Measures with regard to a mother and baby held in the Samos Closed Controlled Access Centre. The Court orders the Greek Authorities to house the applicants in safe and suitable accommodation. UN experts hailed the European Court of Human Rights judgment that Greece had violated a Syrian refugee's right to life when its coastguards shot at a vessel carrying migrants and asylum seekers in 2014. 
#### The Netherlands: The Campaign 'They are already Home' wins Hoogvlieger Award 2023




## Want to relive our 2023 CFJ-EN Child Justice Caravan with the Young Justice Tranformers? Watch this <u>video.</u>

The Child Justice Caravan is a programme run by the Network, enabling children and young people to visit European institutions, meet with key representatives from these institutions and become advocates for change in European systems of justice.

The last Caravan took place on 2-3 December 2023 in Brussels. Belgium. Six young people joined the programme - three from Young Perspectives (YOPE) in the Netherlands and three from Defence for Children (DCI) Greece. The 'Young Justice Transformers' met up with stakeholders to share their experiences and views about children who come into contact with the law.



#### Solitary Confinement: <u>Recent Paper</u>



New CRIN Report Exposes Hazards: Protecting Children's Rights in the EU and Beyond

CRIN's new report uncovers the links between hazardous chemicals and children's rights violations in the European Union (EU) and beyond. It sets out how EU chemical laws fail to uphold children's rights and invites EU decision makers to rethink how to better assess, regulate and restrict those Children's chemicals. rights violations linked to the exposure to hazardous substances have been neglected for too long. 
#### Disciplinary Sanction Regimes in Youth Detention Facilities
